

How to Create Inbound Weight Claim?

1. Create a Purchase Contract, Inbound Shipment against that Purchase Contract.
2. Post Inbound Shipment and Create a Inventory Receipts against the Inbound Shipment. Post IR.
3. Now go to Pending Claim Search Screen.
4. Corresponding Inbound Load No line will be added in Pending Claims search screen.
