Realized Gain or loss Accounts			
1	Accounts payable	General	Gain or loss when a payment is posted to the general ledger difference between the historic transaction rate and the rate entered or system generated at the time of payment
2	Accounts receivable	General	Gain or loss when a payment is posted to the general ledger difference between the historic transaction rate and the rate entered or system generated at the time of payment
3	Fixed Assets	FA Realized Gain or loss	Gain or loss when asset is disposed of - difference between historic rate and the rate at the time of disposal
4	Gain on forward	Forward Accrual Realized gain or loss	Gain or loss on final posting of the forward - this is the historic rate vs the rate at the time of posting - this is for cash management forward transactions
5	Gain on Swap	Swap Accrual Realized gain or loss	Gain or loss on final posting of the forward - this is the historic rate vs the rate at the time of posting - this is for cash management swap transactions
6	Cash management	Cash management realized gain or loss	Gain or loss on revaluation of cash accounts on a monthly basis from the general ledger
7	Forex Difference	General	This is the difference in a foreign currency transaction due to rate spread
